Technology, Access to Justice and Rule of Law – Report available

Technology has the potential to unlock justice for all, according to a new report launched by the Law Society. However, it is by no means a 'silver bullet'. Based on an assessment of 50 initiatives and qualitative interviews with more than 45 stakeholders, the report explores whether technology is the key to unlock the potential of law, justice and rights. It concludes



that, with the right support from government, technology can be the key to unlocking access to justice innovation.
